## Emergency Sexual Assault Services (ESAS):

This program provides support, counselling, and court preparation for survivors of sexual assault. Referrals may come from any source and there are no age restrictions.

#### Counselling Program:

This program offers counselling to children, youth, and their families based on their needs. Each of these programs may include individual counselling for the child or youth, parent support and education, or family therapy.

## Early Years Parenting Support Program (EYPSP):

This program offers prevention and early intervention services for parents to strengthen family resiliency. Services include individual parent support sessions and interactive / psycho-educational groups for expectant parents, parents, and caregivers with children aged 0–5.

#### **CVSS Program Focus:**

Cameray's Child Victim Support Service provides support to children and youth (under the age of 19) who are victims or witnesses of crime, along with their non-offending family members.

Referrals must meet the following criteria: clients must either reside in Burnaby or New Westminster, and/or have court proceedings that take place in New Westminster or Vancouver (for Burnaby cases).

Program involvement is voluntary and can begin at any stage of the legal process.

#### We can help by...

Support can be provided over the phone and / or in person, depending on your needs. For children and youth who are subpoenaed to testify in court, several court preparation sessions can be arranged with the Victim Support Worker prior to attending court.

- Offer emotional support during the police investigation(s) and court proceedings
- Provide resources and referrals to various community agencies
- Assist with safety planning

- Assist with justice-related forms and applications (such as the Crime Victim Assistance Program and Victim Impact Statements)
- Help victims prepare for testifying in court
- Accompaniment to court and justice-related meetings
