Other Programs Offered at Cameray:

Child & Youth Victim Support Services (CVSS):

This program provides support and court preparation for children and youth who have witnessed or been the victim of a crime. Referrals can come from any source.

Counselling Program:

This program offers counselling to children, youth, and their families based on their needs. Each of these programs may include individual counselling for the child or youth, parent support and education, or family therapy.

Early Years Parenting Support Program (EYPSP):

This program offers prevention and early intervention services for parents to strengthen family resiliency. Services include individual parent support sessions and interactive / psycho-educational groups for expectant parents, parents, and caregivers with children aged 0-5.

Cameray's Emergency Sexual Assault Services Program provides victim services and / or counselling for survivors of sexual assault with a focus on Burnaby and New Westminster.

Participation is voluntary and involvement can begin at any stage of the legal process.

We can help by...

- Support can be provided virtually and / or in person, depending on your needs
- Court accompaniment can be provided for clients that have received a subpoena to testify in court
- Several court preparation sessions can be arranged with the victim support worker prior to attending court
- For additional support, counselling sessions with a Registered Clinical Counsellor can be provided

WHAT WE DO:

- Offer emotional support during the reporting process, police investigation(s) and court proceedings
- Provide resources and referrals to various community agencies when supporting clients through the criminal justice system process
- Provide counselling services by Registered Clinical Counsellor
- Accompaniment to medical appointments / hospital
- Assist with safety planning
- Help explain the criminal justice process and the roles within (e.g., Police, Crown Counsel, Judge, etc.)
- Provide updates on the status of investigations and / or court proceedings
- Assist with justice-related forms and applications (such as the Crime Victim Assistance Program applications, Victim Impact Statements, etc.)
- Help victims prepare for testifying in court
- Accompany victims / witnesses to court and justice-related meetings
